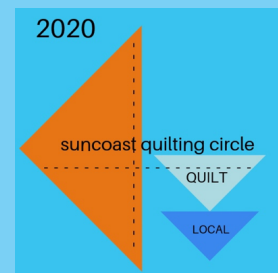

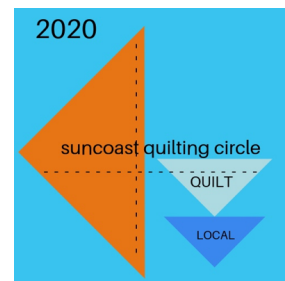

NEW LOCATION: The Coliseum, 535 4th Avenue North, St. Petersburg, FL 33701

SET-UP: Thursday, March 19, 2020 (hours 12 pm - 5 pm)

SHOW HOURS: Friday, March 20, 2020 10:00 am – 6:00 pm/Saturday, March 21, 2020 10:00 am – 5:00 pm

TAKE-DOWN: Saturday March 21, 2020 5:00 pm – 7:00 pm

1. **BOOTH FEE:** Standard 8' x 16'.... \$250. Premium Booth 14' x 15' ...\$500. WiFi is provided. **ELECTRIC SERVICE FEE of \$60 per booth must be paid with FINAL PAYMENT and received by January 15, 2020. ELECTRIC SERVICE ordered at SHOW SET-UP will be charged \$80 per booth. FINAL PAYMENT and ELECTRIC SERVICE FEE are due JANUARY 15, 2020 and are NONREFUNDABLE.**
2. **Vendor may not sublet booth.**
3. **DECORATING.** The following items will not be permitted when decorating the walls, floors, ceiling or stages: bolts, screws, nails, staples, scotch tape, electric tape, duct tape and glue. All decorations or props must be removed from the building within two (2) hours following the event.
4. **SIGNS:** Vendors will provide their own signs.
5. **HOURS OF OPERATION:** Vendors will have booth open and attended at all times during SHOW HOURS. TAKE-DOWN booth immediately at the close of the show but not before the show closes. You will have two hours to vacate the Coliseum.
6. **INSURANCE:** Vendor will provide Commercial General Liability Insurance covering all claims or demands that may arise or be claimed on account of Vendor's use of the Coliseum in the amount of at least \$1,000,000 per occurrence and \$2,000,000 aggregate including damage to Coliseum in an amount of at least \$100,000. A standard ACORD Certificate of Liability will be required on January 15, 2020, that shall list Suncoast Quilting Circle, the Coliseum and the City of St. Petersburg as additional insured. Policy due at time of FINAL PAYMENT.
7. **DISCLAIMER:** Suncoast Quilting Circle, The Coliseum and/or the City of St. Petersburg are not liable for fire, theft, accidents, damage, loss or injury to vendors, vendor's property, vendor's employees or assistants.
8. **SMOKING.** Smoking is not permitted in the Coliseum.
9. **FL STATE TAX:** In compliance with Florida and Pinellas County law sales tax in the amount of 7% must be collected on every sale.
10. **DEPOSIT:** A DEPOSIT of \$100 is due with the completed VENDOR CONTRACT. Make checks payable to Suncoast Quilting Circle and send to the address at the bottom of the contract.
11. **CANCELLATION/REFUND POLICY:** Our refund policy is as follows: On or before November 15, 2019: 100% of funds received. Between November 15, 2019 and December 15 2019: 75% of funds received. Between December 15, 2019 and January 15, 2020: 50% of funds received. After January 15, 2020: No refunds. Cancellations will not be accepted after January 15, 2020, except for extreme emergencies, which will be decided on an individual basis.
12. **ACCEPTANCE OF VENDOR:** The SQC 2020 Quilt Show Vendor Coordinator and Show Chair(s) reserve the right to make all decisions concerning acceptance, suitability and all other issues regarding vendors. Spaces will be reserved in the order deposits are postmarked and received.
